

# Proposed changes to the PLAYERS Constitution

Please find below a comprehensive list of the 16 proposed Constitutional changes, listed in order of appearance. Each should be reviewed and voted on individually in the 48 hours prior to the AGM.

Note that all changes come at the recommendation of the PLAYERS Board of Directors. **Green indicates additions, red indicates subtractions.**

\*\*\*\*Ratified with 100% of the votes cast (46/46 - out of 48 eligible)

1. Revision to **Part I. Name** to update the legal name of PLAYERS\*:

In the event where a Board Member chooses to apply and/or submit, that person will not be permitted to view, comment, or vote upon the particular area in which they have applied/submitted.

Roles and Duties of the Board of Directors**, to ensure that each new Board takes appropriate action to accommodate the needs of each Board member so that they can most fully participate.

10. Revision to **Bylaw III. Show profits and charitable donations, Section 1**, to reflect the proposed revision to the 3<sup>rd</sup> guiding principal:

1. The profits of each show will be divided up in accordance with the following formula:

$$a - b = c$$

$$c - y = z$$

Where:

a = Total Income

b = Total Expenditures

c = Total Proceeds

y = Replenish PLAYERS operating and strategic reserves

z = **Net Proceeds** – given to charity

### **III. Show profits and charitable donations:**

1. The profits of each show will be divided up in accordance with the following formula:

$$a - b = c$$

$$c - y = z$$

Where:

a = Total Income

b = Total Expenditures

c = Total Proceeds

y = Replenish PLAYERS operating and strategic reserves

z = **Profits** – given to charity

12. <sup>\*\*\*\*Ratified with 100% of the votes cast (46/46 - out of 48 eligible)</sup> New Bylaw added to **Bylaw III. Show profits and charitable donations**, to add some guidance for how charities should be chosen by the Board.

5. **In deciding which charities to support each season, the Board will seek out and consider the suggestions and priorities of the Players community. The Board will consider strongly charities that focus on advocating for, and supporting, members of our community and the community at large.**

13. Revision to **Bylaw IV. Outside and outreach ventures, Section 2**, to remove problematic language and add new Bylaw with much improved language.

2. It is suggested that PLAYERS to attempt to bring in roughly 25% new members for each production. **This, however, should never be done at the expense of the quality of the show.**

3. The board will strive to get input from BIPOC individuals on key matters that affect our community where those voices are not represented on the Board, and to the extent possible, encourage BIPOC members to run for the Board.

14. Revision to **Bylaw V. Reservation of seats, Section 1**, to allow for the producer to choose to reserve seats for large groups – this is something we already do.

15. Revision to **Bylaw VII. Artistic Director, Section 3**, to clarify when they can and cannot vote as a Voting Member of Players.

3. The Artistic Director is not a member of the Board, and is required to relinquish **all** rights as a Voting Member of Players for the duration of their term **so as to avoid** conflict of interest.

The Artistic Director is not a member of the Board and is required to relinquish **any** rights as a Voting Member of Players for the duration of their term **that might cause** conflict of interest, **including voting for the Board and any constitutional changes that directly affect the Artistic Director.**
